Property development raises Sentoria's 3rd quarter financial performance

- Records RM11 million pre-tax profit in 3Q14
- Recorded 78% sales on its newly launched Taman Bukit Gambang

Kuala Lumpur, Malaysia, 26 August 2014 - Sentoria Group Berhad (Sentoria; 建乐集团, Bloomberg: SNT:MK, Reuters: SNTO.KL), property developer and operator of Bukit Gambang Resort City (BGRC), released its financial results for the third quarter ended 30th June 2014 (3Q14) today. The group recorded revenue of RM56.4 million with group pre-tax profit stood at RM11 million with net profit stood at RM8.2 million. The 3Q14 revenue shows a slight improvement 0f 1.7% from the same period last financial year, while the pre-tax profit improves by 11.5% as compared to the same period last year.

For the three cumulative quarters ended 30 June 2014, the Group recorded revenue of RM154 million, of which the property development division contributed approximately 70% or RM108 million, while the leisure and hospitality division made up the balance with RM45.5 million in revenue. A 12% jump in revenue from property development division goes to show that the demand for its property is still strong.

Despite the higher operating cost for BGRC, with the opening of its Bukit Gambang Safari Park this financial year coupled with business affected by the flood (in December 2013), the group is still able to record a 5% increment in its after tax profit which stood at RM19 million as compared to RM18 million for the same period last year.

Since its opening in mid-2009, *BGWP* has attracted about 2 million visitors so far, and been awarded the Best Large Water Park Award in 2011 by the Malaysian Association of Amusement, Theme Park and Family Attractions (MAATFA).

Its *Arabian Bay Resort* has made it to the Malaysia Book of Records for the 'Largest Pillarless Ballroom in Malaysia' - capable of holding 3,100 pax in banquet-style seating.
