1. INTRODUCTION

The Anti-Bribery and Corruption Policy ("ABC Policy" or "the Policy") has been developed to

comply with the requirements set out in the Bursa Malaysia Securities Berhad Main Market Listing

Requirements in relation to the Anti-Corruption Measures. The Policy represents the Company's

commitment to have an adequate procedures in place to prevent any persons associated with Meta

Bright from undertaking the corrupt conduct. The Policy should be read in conjunction with the

Company's various policies & guidelines.

2. ANTI-BRIBERY AND CORRUPTION COMMITMENT

Meta Bright is committed to conducting business dealings with integrity. This means avoiding

practices of bribery and corruption of all forms in the Company's daily operations.

The Company has adopted a zero-tolerance approach against all forms of bribery and corruption.

Employees who refuse to pay bribes or participate in acts of corruption will not be penalised even

if such refusal may result in losing of business.

The Policy leverages on the values and core principles set out in the Code of Business Ethics. Full

compliance to both the spirit and the letter of this Policy is mandatory and should be maintained

using a principle-based approach.

3. OBJECTIVE

This policy sets out Meta Bright's overall position on bribery and corruption in all its forms

and its Standard Operating Procedures in relation to such activities.

4. SCOPE

This policy is applicable to Meta Bright, its controlled organisations, business associates acting on

Meta Bright's behalf, the Board of Directors and all Meta Bright's personnel.

Joint-venture companies in which Meta Bright is non-controlling or co-venture and associated

companies are encouraged to adopt these or similar principles. External Providers are also expected

to comply with this policy in relation to all work conducted with Meta Bright, or on Meta Bright's

behalf.

## 5. **DEFINITIONS**

"ABC Policy" or "Policy" means Anti-Bribery and Corruption Policy;

"Audit and Risk Management Committee" means the Audit and Risk Management Committee of the Board of Directors of Meta Bright;

"Bribery & Corruption" means any action which would be considered as an offence of giving or receiving 'gratification' under the Malaysian Anti-Corruption Commission Act 2009 (MACC Act). In practice, this means offering, giving, receiving or soliciting something of value in an attempt to illicitly influence the decisions or actions of a person who is in a position of trust within an organisation.

Bribery may be 'outbound', where someone acting on behalf of Meta Bright attempts to influence the actions of someone external, such as a Government official or client decision-maker. It may also be 'inbound', where an external party is attempting to influence someone within the Company such as a senior decision-maker or someone with access to confidential information.

## "Gratification" is defined in the MACC ACT to mean the following:

- (a) money, donation, gift, loan, fee, reward, valuable security, property or interest in property being property of any description whether movable or immovable, financial benefit, or any other similar advantage;
- (b) any office, dignity, employment, contract of employment or services, and agreement to give employment or render services in any capacity;
- (c) any payment, release, discharge or liquidation of any loan, obligation or other liability, whether in whole or in part;
- (d) any valuable consideration of any kind, any discount, commission, rebate, bonus, deduction or percentage;
- (e) any forbearance to demand any money or money's worth or valuable thing;
- (f) any other service or favour of any description, including protection from any penalty or disability incurred or apprehended or from any action or proceedings of a disciplinary, civil or criminal nature, whether or not already instituted, and including the exercise or the forbearance from the exercise of any right or any official power or duty; and
- (g) any offer, undertaking or promise, whether conditional or unconditional, of any gratification within the meaning of any of the preceding paragraphs (a) to (f).

"Business Associate" means an external party with whom Meta Bright has, or plans to establish, some form of business relationship. This may include clients, customers, joint ventures, joint venture partners, consortium partners, outsourcing providers, contractors, consultants, subcontractors, suppliers, vendors, advisers, agents, distributors, representatives, intermediaries and investors.

"Conflict of Interest" means when a person's own interests either influence, have the potential to influence, or are perceived to influence their decision making at Meta Bright.

"Controlled organisation" means an entity where Meta Bright has the decision-making power over the organisation such that it has the right to appoint and remove the management. This would normally be where Meta Bright has the controlling interest (>50% of the voting share ownership), but it could be where there is an agreement in place that Meta Bright has the right to appoint the management, for example a joint venture where Meta Bright has the largest (but still <50%) allocation of the voting shares;

"Corporate Gift" means something given from one organisation to another, with the appointed representatives of each organisation giving and accepting the gift. Corporate gifts may also be promotional items given out equally to the general public at events, trade shows and exhibitions as a part of building the Company's brand. The gifts are given transparently and openly, with the implicit or explicit approval of all parties involved. Corporate gifts normally bear the Company name and logo. Examples of corporate gifts include items such as diaries, table calendars, pens, notepads and plaques.

"Donation & Sponsorship" means charitable contributions and sponsorship payments. Examples include sponsorship of educational events, supporting NGOs, and other social causes;

**"Exposed Position"** means a staff position identified as vulnerable to bribery through a risk assessment. Such positions may include any role involving: procurement or contract management; financial approvals; human resource; relations with government officials or government departments; sales; positions where negotiation with an external party is required; or other positions which the Company has identified as vulnerable to bribery;

"Hospitality" means the considerate care of guests, which may include refreshments, accommodation and entertainment at a restaurant, hotel, club, resort, convention, concert, sporting event or other venue such as Company offices, with or without the personal presence of the host. Provision of travel may also be included, as may other services such as provision of guides, attendants and escorts; use of facilities such as a spa, golf course or ski resort with equipment included;

"Meta Bright" or "Company" means Meta Bright and its group of companies;

"Personnel" means directors and all individuals directly contracted to the Company on an

employment basis, including permanent and temporary employees.

6. ANTI-BRIBERY AND CORRUPTION POLICY

**6.1** Bribery and corruption in all its forms as it relates to Meta Bright's activities is prohibited.

**6.2** Bribery and corruption may take the form of anything of value, such as money, goods,

services, property, privilege, employment position or preferential treatment.

Meta Bright personnel and its business associates shall not, whether directly or indirectly,

offer, give, receive or solicit any item of value, attempt to illicitly influence the decisions or

actions of a person in a position of trust within an organisation, either for the intended benefit

of Meta Bright or the persons involved in the transaction.

6.3 The anti-bribery and corruption statement applies equally to its business dealings with

commercial ('private sector') and Government ('public sector') entities, and includes their

directors, personnel, agents and other appointed representatives. Even the possible

appearance of bribery or corruption is to be avoided, in particular when dealing with

Government officials.

**6.4** No employee or external party will suffer demotion, penalty or other adverse consequences

in retaliation for refusing to pay or receive bribes or participate in other illicit behaviour

which eventually caused the company to lose certain business.

6.5 Meta Bright is also committed to conducting due diligence checks on prospective personnel,

particularly as it relates to appointments to positions where a more than minor bribery or

corruption risk has been identified.

7. WHISTLEBLOWING POLICY

**7.1** The Board is committed to maintain and achieve high standard of corporate integrity.

Towards this end, the Board has defined and provided this whistle blowing policy and

procedure to guide the employees and stakeholders to whistle blow any wrongdoings and

violation of the Code of Conduct and Ethics and to provide protection to the whistleblower.

Parties can report a Whistleblowing complaint if they are aware of any wrongdoings, including, but not limited to the following:

- fraud;
- misappropriation of assets;
- sexual harassment;
- criminal breach of trust:
- illicit and corrupt practices;
- questionable or improper accounting;
- misuse of confidential information;
- acts or omissions which are deemed to be against the interest of the Company, laws, regulations, or public policies;
- giving false or misleading information (including suppression of any material facts or information);
- breaches of Group Policies and Code of Business Conduct (COBC); or
- the deliberate concealment of any of the above matter or other acts of wrongdoings

## 7.2 Acting in Good Faith

We expect all parties to act in good faith and have reasonable grounds when reporting a Whistleblowing complaint. If allegations are proven to be malicious, parties responsible may be subject to appropriate action, up to and including legal action, where applicable.

#### 7.3 Protection from Retaliation

Any party that retaliates against someone who has reported a wrongdoing in good faith may be subject to appropriate action, up to and including legal action, where applicable.

## 7.4 Whistle Blowing Channel

Stakeholders who knows of, or suspects a violation of the Code may report the incidence to the Board Chairman or the ARMC Chairman by emailing to mbgb@whistleblower.com.my or posting to PO Box #911, L2- 08, Level 2, Cheras Leisure Mall, Jalan Manis 6, Taman Segar, 56100 Kuala Lumpur.

The Internal Auditors shall maintain a record of the complaints received and on quarterly basis, prepare a summary report and present it to the Audit and Risk Management Committee.

## 8. GIFTS, DONATIONS AND SPONSORSHIPS

- **8.1** With regard to Meta Bright personnel receiving gifts, unless approval has been provided by the respective Head Of Departments, gifts that exceed a RM500 threshold must be declined and recorded. Gifts in the form of cash must never be accepted. The test to be applied is whether in all the circumstances, the gift is reasonable and justifiable. We expect the intention behind the gift to always be considered.
- **8.2** The only form of gift-giving allowed to external parties is a corporate gift. Any gift-giving or event of hospitality is subject to the following conditions:
  - a) They are limited, customary and lawful under the circumstances;
  - b) They do not have or are perceived to have (by either the giver or the receiver), any effect on actions or decisions.
  - There must be no expectation of any specific favour or improper advantages from the intended recipients;
  - d) The independent business judgment of the intended recipients must not be affected;
  - e) There must not be any corrupt / criminal intent involved; and
  - f) The giving out of the gift and hospitality must be done in an open and transparent manner.
- **8.3** Donations and sponsorships are permitted. However, the Company prohibits the giving and receiving of donations and sponsorships to influence business decisions.
- **8.4** All sponsorships and donations by the Group to institutional organisations shall be recorded, documented and supported by formal request and acknowledgement of receipt by the intended recipients in order to promote transparency and to safeguard the reputation of the Group from any allegations of bribery.

## 9. FACILITATION PAYMENTS

**9.1** Meta Bright adopts a strict policy of disallowing the use of facilitation payments in its business. Facilitation payment is a payment or other provision made personally to an individual in control of a process or decision. It is given to secure or expedite the performance of a routine or administrative duty or function.

**9.2** Personnel shall decline to make the payment and report to the respective heads of department immediately when they encounter any requests for a facilitation payment. In addition, if a payment has been made and personnel are unsure of the nature, the respective heads of department must be notified immediately, and the payment recorded accordingly.

## 10. REFERRAL

- **10.1** Meta Bright prohibits referral payment to Government officials; individuals representing any regulatory authorities ("Regulatory Representative"); and any nominee identified by these Regulatory Representative.
- **10.2** All referral payments shall only be made in accordance with the market and industry norm and shall be subjected to the approval of the Management.
- 10.3 In order to avoid any potential and perceived conflict of interest, directors or employees shall disclose their interest and abstain from deliberation and/or voting on the transactions involving referral payment payable to them or their immediate family members.
- **10.4** All referral payments made shall be recorded, documented and compiled for periodic review by the Audit and Risk Management Committee.

## 11. SUPPORT LETTERS

**11.1** Meta Bright awards contracts and employee positions purely on a merit basis. Therefore, support letters in all forms shall not be recognised as part of the business decision making process.

## 12. RECRUITMENT, PROMOTION AND SUPPORT OF PERSONNEL

- **12.1** Meta Bright recognises the value of integrity in its personnel and business associates. The Company's recruitment, training, performance evaluation, remuneration, recognition and promotion for all Meta Bright personnel, including management, shall be designed and regularly updated to embed and recognize integrity assurance.
- **12.2** Meta Bright does not offer employment to prospective personnel in return for their having improperly favoured the Company in a previous role.

#### 13. BUSINESS ASSOCIATES

- **13.1** All business associates (including external providers such as consultants, advisors, and agents) acting on behalf of Meta Bright are required to comply with this Policy, and all other policies (if any) as it relates to them.
- 13.2 In circumstances where Meta Bright retains controlling interest, such as in certain joint venture agreements, business associates are required to adhere to the ABC Policy. Where Meta Bright does not have controlling interest, Meta Bright's Anti Bribery And Corruption Policy shall be made known to the associates and they are encouraged to comply to the same.
- 13.3 Due diligence should also be carried out with regards to any business associates intending to act on the Company's behalf as an agent or in other representative roles, to ensure that the entity is not likely to commit an act of bribery or corruption in the course of its work with Meta Bright.
- 13.4 The extent of the due diligence should be based on a bribery and corruption risk assessment. Due diligence may include a search through relevant databases, checking for relationships with public officials, self-declaration, and documenting the reasons for choosing one particular Business associate over another.
- 13.5 Meta Bright shall include standard clauses in all contracts with business associates enabling the Company to terminate the contract in the event that bribery or an act of corruption has been proved to occur. Additional clauses may also be included for business associates acting on Meta Bright's behalf where a more than minor bribery risk has been identified.

## 14. RESPONSIBILITIES OF META BRIGHT PERSONNEL

- **14.1** All Meta Bright personnel (including its directors, and directors and personnel of its controlled organisations) are required to carry out those responsibilities and obligations relating to the Company's anti-bribery and corruption stance, alongside those already in existence, which includes the following:
  - a) Be familiar with applicable requirements and directives of the policy and communicate them to subordinates;
  - b) Promptly record all transactions and payments in Meta Bright's books and records accurately and with reasonable detail;
  - c) Ask the respective heads of department if any questions about this policy arise or if there is a lack of clarity about the required action in a particular situation;
  - Always raise suspicious transactions and other "red flags" (indicators of bribery or corruption) to immediate superiors for guidance on the next course of action;
  - e) Be alert to indications or evidence of possible violations of this policy;
  - f) Promptly report violations or suspected violations through appropriate channels;
  - Attend required anti-bribery and corruption training as required according to position;
    and
  - h) Not misuse their position or Meta Bright's name for personal advantage.
- 14.2 When dealing with business associates, all Meta Bright personnel shall not:
  - a) express unexplained or unjustifiable preference for certain parties;
  - b) make any attempt at dishonestly influencing their decisions by offering, promising or conferring advantage;
  - c) exert improper influence to obtain benefits from them;
  - d) directly or indirectly offer or make promise or corrupt payments, in cash or in kind for a specific favour or improper advantage from them.

- **14.3** During an active or anticipated procurement or tender exercise, personnel participating in the exercise in any way whatsoever, shall not:
  - a) receive gifts or hospitality or any kind from any external party participating, planning to participate, or expected to participate, in the procurement or tender exercise;
  - b) provide anything other than a corporate gift and token hospitality to any external/third party related to the exercise;
  - be involved in any discussions regarding business or employment opportunities, for personal benefit or for the benefit of a business associate;
  - d) abuse the decision-making and other delegated powers given by the top management; and
  - e) bypass normal procurement or tender process and procedure.
- **14.4** When dealing with external parties in a position to make a decision to Meta Bright's benefit (such as a Government official or client), Meta Bright personnel shall not:
  - a) offer, promise or make any attempt at dishonestly influencing the person's decision by directly or indirectly offer or make promise of corrupt payments, in cash or in kind;
  - b) be involved in any discussions regarding business or employment opportunities, for their own personal benefit or for the benefit of the external party;
  - otherwise abuse the decision-making and other delegated powers given by the top management, in order to illicitly secure an outcome which would be to the commercial advantage to themselves and/or the Company; and
  - d) exert improper influence to obtain personal benefits from them.
- 14.5 Meta Bright's managers have a particular responsibility to ensure that the ABC's requirements are applied and complied with within their department or function and to monitor compliance with the policy. They also must ensure that subordinates in 'Exposed Positions' attend relevant training.

## 15. CONFLICTS OF INTEREST

- 15.1 Conflicts of interest arise in situations where there is personal interest that could be considered to have potential interference with objectivity in performing duties or exercising judgment on behalf of the Company. All personnel should avoid situations in which personal interest could conflict with their professional obligations or duties. Personnel must not use their position, official working hours, Company's resources and assets, or information available to them for personal gain or to the Company's disadvantage.
- **15.2** In situations where a conflict does occur, personnel are required to declare the matter as per the Employees Handbook.

## 16. STAFF DECLARATIONS

- **16.1** All Meta Bright personnel shall certify in writing that they have read, understood and will abide by this policy. A copy of this declaration shall be documented and retained by the Human Resources Department for the duration of the personnel's employment. A sample declaration can be found in the **Appendix** of this Policy
- **16.2** The Company reserves the right to request information regarding an employee's assets in the event that the person is implicated in any bribery and corruption-related accusation or incident.

#### 17. ANTI-BRIBERY AND CORRUPTION COMPLIANCE FUNCTION

- 17.1 Meta Bright shall establish and maintain an anti-bribery and corruption compliance function within the Administrative Department to oversee the design, implementation and management of the ABC.
- **17.2** They shall perform functions below within the Company structure, equipped to act effectively against bribery and corruption:
  - a) provide advice and guidance to personnel on the ABC and issues relating to bribery and corruption;
  - b) take appropriate steps to ensure that adequate monitoring, measurement, analysis and evaluation of the ABC is performed;

- c) report on the implementation of the ABC to the top management and Audit and Risk Management Committee regularly.
- 17.3 Meta Bright shall conduct regular risk assessments to identify the bribery and corruption risks affecting the business, set anti-bribery and corruption objectives, and assess the effectiveness of the controls in achieving those objectives.

#### 18. TRAINING AND AWARENESS

- **18.1** Meta Bright shall conduct an awareness programme for all its personnel on the Company's position regarding anti-bribery and corruption, integrity and ethics.
- **18.2** Training shall be provided on a regular basis, in accordance with the level of bribery and corruption risk related to the position. Training should be provided to personnel who are:
  - a) new to the Company;
  - b) appointed to or currently holding an exposed position.
- **18.3** Human Resources Department shall maintain records to identify which Meta Bright personnel have received training, and produce, communicate and update the training schedule in conjunction with Administrative Department.
- **18.4** Business associates acting on behalf of the Company shall also undergo appropriate training, where a bribery and corruption risk assessment identifies them as posing a more than minor bribery and corruption risk to the Company.

## 19. REPORTING OF POLICY VIOLATIONS

- **19.1** Suitable reporting channels shall be established and maintained for receiving information regarding violations of this policy, and other matters of integrity provided in good faith by Meta Bright personnel and/or external parties.
- 19.2 Personnel who, in the course of their activities relating to their employment at Meta Bright, encounter actual or suspected violations of this policy are required to immediately report their concerns to their superior or report through the reporting channels stated in Whistleblowing Policy.

- **19.3** Reports made in good faith, either anonymously or otherwise, shall be addressed in a timely manner and without incurring fear of reprisal regardless of the outcome of any investigation.
- 19.4 Retaliation in any form against Meta Bright personnel where the person has, in good faith, reported a violation or possible violation of this policy is strictly prohibited. Any Meta Bright personnel found to have deliberately acted against the interests of a person who has in good faith reported a violation or possible violation of this policy shall be subjected to disciplinary proceedings including demotion, suspension, dismissal or other actions (including legal action) which Meta Bright may pursue.

## 20. AUDIT AND COMPLIANCE

Regular audits shall be conducted to ensure compliance to this policy. Such audits may be conducted internally by Meta Bright or by an external party. Audit documentation should include performance improvement action plans.

## 21. SANCTIONS FOR NON-COMPLIANCE

- 21.1 Non-compliance as identified by the audit and any risk areas identified through this and other means should be reported to the top management and Audit and Risk Management Committee in a timely manner in accordance with the level of risk identified.
- 21.2 Meta Bright regards bribery and acts of corruption as serious matters and will apply penalties in the event of non-compliance to this policy. For Meta Bright personnel, non-compliance may lead to disciplinary action, up to and including termination of employment.
- **21.3** For external parties, non-compliance may lead to penalties including termination of contract. Further legal action may also be taken in the event that Meta Bright's interests have been harmed by the results of such non-compliance by individuals and organisations.

#### 22. CONTINUOUS IMPROVEMENT

**22.1** Meta Bright shall monitor the legal and regulatory regimes where it operates and any changes to Meta Bright's business environment and risks and identify opportunities for ABC improvement.

- **22.2** Regular assessments of the ABC should be carried out to ensure its scope, policies, procedures and controls match the bribery and corruption related risks faced by the Company.
- 22.3 Meta Bright endeavours to impact the business environment where it operates. This includes extending its integrity programme to non-controlled business associates such as suppliers and contractors, seeking to work with companies who have a similar commitment and supporting initiatives in the private and public sectors which are likely to improve the integrity of its operating environment.
