










GROUP REVENUE MIX




CAR SEAT COVERS SUB-SEGMENT REVENUE MIX



FY2019 - FY2023 NET PROFIT CAGR: 16.3%




REVENUE (RM MILLIONS) PAT (RM MILLIONS) NET PROFIT MARGIN










Overview of our Purchasing Processing Flow:





Assumes share base of 752 million




